## DRP Election via NZX

1. Complete the DRP Election Notice online at PLPF's Unit Registrar, Link Market Services Limited:

2. Select **BIML – Booster Investment Management Limited** as the issuer from the dropdown box on the page. You will be required to enter your CSN/Holder Number and FIN before you can make your Participation Election.
3. Once you have entered these details, click **Payment and Tax**, then **Reinvestment Plans**, and tick the applicable box to participate in the Plan.
4. If you make an online election, you will be required to confirm that you have read, understood and complied with the terms and conditions of the Plan. Joint and corporate unitholders will need to register a portfolio to update their participation election; or;
5. Complete this DRP Election Notice and send to Link Market Services (details in blue box above).
