#### What is the purpose of this update?

This document tells you how the **Enhanced Cash Portfolio** has performed and what fees were charged. #### **Description of this fund**

The Enhanced Cash Portfolio invests entirely in income assets. It is suited to investors looking for an on-call investment with a low level of risk and are willing to accept a relatively modest level of returns.

#### What are the risks of investing?



#### Example of how this applies to an investor

Ruby had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ruby received a return after fund charges and tax were deducted of \$31 (that's 0.31% of her initial \$10,000). Ruby also paid \$0.00 in other charges. This gives Ruby a total return after tax of \$31 for the year.
