

## Quarterly Disclosure Statement for 1 January 2013 to 31 December 2013

Name of KiwiSaver scheme: *Grosvenor KiwiSaver Scheme*

Name of KiwiSaver fund: *Geared Growth Fund*

### What is the purpose of this statement?

This statement provides key information about the **Grosvenor KiwiSaver Scheme's Geared Growth Fund**. It tells you how the fund has performed and what fees it charged, and will help you compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

### Description of the fund

The Geared Growth Fund invests almost entirely in growth assets and uses leverage, through borrowing, to increase the total exposure to New Zealand, Australian and other international shares as it seeks to maximise returns for savers over the long term.

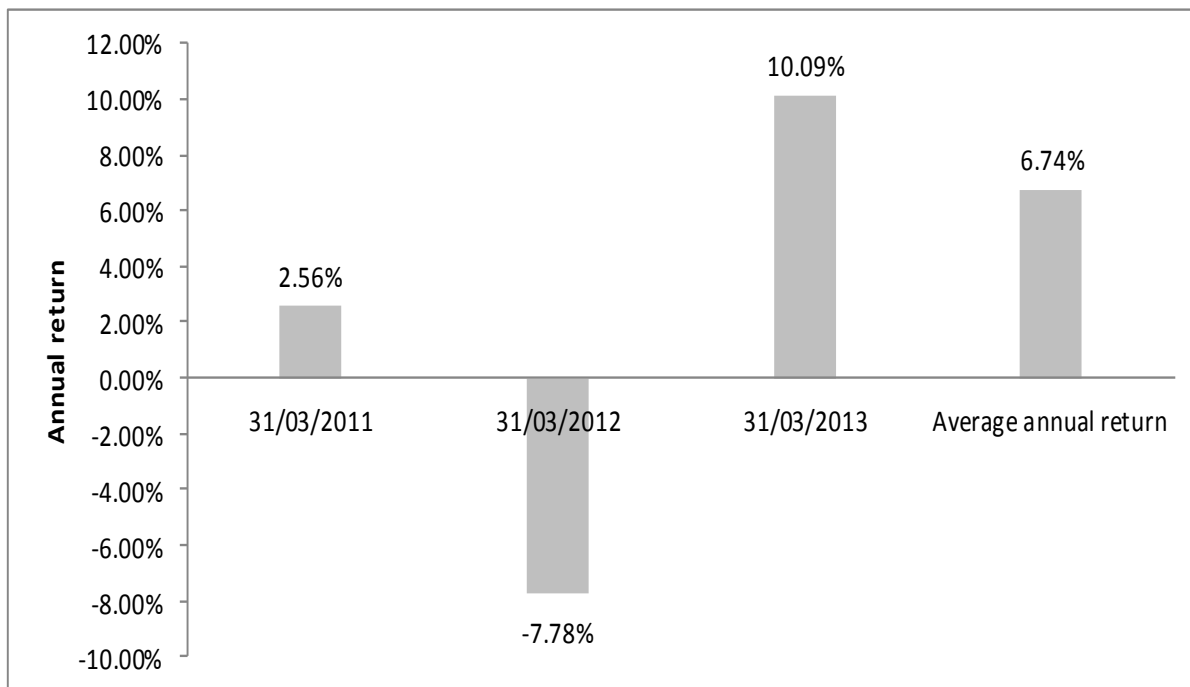

### How has the fund performed in the past?

### What fees were members charged?

The returns above are after deductions for **fund fees**<sup>2</sup>. These fees were last totalled up for the year to 31 March 2013 and were:

Members were also charged **membership fees**<sup>4</sup> of \$39.96 over the year to 31 March 2013.

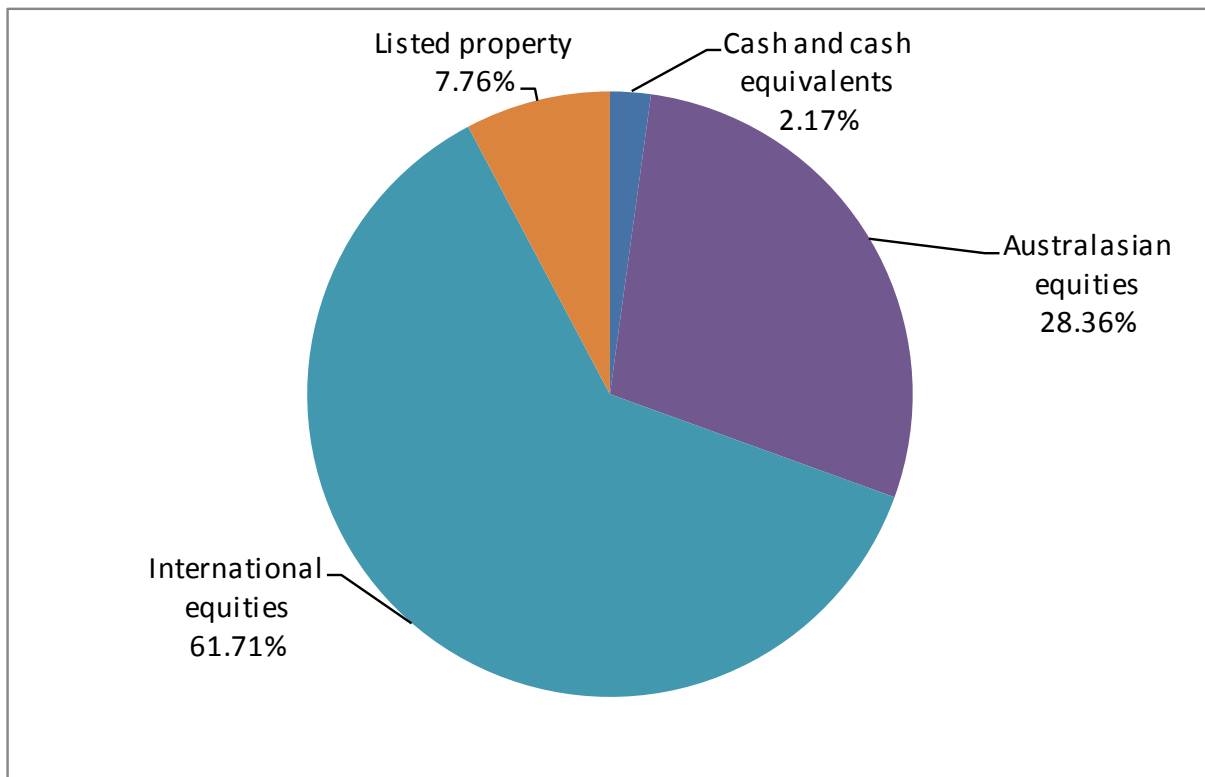

### Example of how this applies to a member

Mr Smith had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Mr Smith received a return after fund fees and tax were deducted of \$1,357 (that's 13.57% of his initial \$10,000). Mr Smith also paid \$39.96 in membership fees. This gives Mr Smith a total return of \$1,317.04 for the year.

<sup>3</sup> The total fund fees for the 12 months period to 31 December 2013 were 1.47%, which materially differ from the total fund fees for the period to 31 March 2013 of 1.33%, because a gearing fee was charged from November 2013.
