Name of KiwiSaver scheme: Grosvenor KiwiSaver Scheme Name of KiwiSaver fund: Socially Responsible Investment Fund

What is the purpose of this statement?

This statement provides key information about the *Grosvenor KiwiSaver Scheme's Socially Responsible Investment Fund*. It tells you how the fund has performed and what fees it charged, and will help you compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The Socially Responsible Investment Fund invests, either directly or through other funds, in shares mainly listed on the Australian and New Zealand stock exchanges, but augmented with companies listed on other major global stock exchanges and more income-generating investments. The portfolio will exclude companies and other investments where the underlying activities are principally involved in the tobacco, alcohol, gambling and armaments industries. The criteria for screening out these companies may be modified over time to reflect developments in the socially responsible investment arena.



How has the fund performed in the past?

What fees were members charged?

The returns above are after deductions for *fund fees*². These fees were last totalled up for the year to 31 March 2013 and were:

Members were also charged *membership fees*³ of \$39.96 over the year to 31 March 2013.



Example of how this applies to a member

Mr Smith had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Mr Smith received a return after fund fees and tax were deducted of \$508 (that's 5.08% of his initial \$10,000). Mr Smith also paid \$39.96 in membership fees. This gives Mr Smith a total return of \$468.04 for the year.
