Grosvenor KiwiSaver Scheme International Share Fund

What is the purpose of this statement?

This statement provides key information about the Grosvenor KiwiSaver Scheme International Share Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of th fund

The International Share Fund invests, either directly or through other funds, in shares listed on the world's major stock exchanges. The portfolio will include a balanced mix of index-type funds and actively managed funds and shares.




Example of how this applies to a member

Mr Smith had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Mr Smith received a return after fund fees and tax were deducted of \$1,523 (that's 15.23% of his initial \$10,000). Mr Smith also paid \$39.96 in membership fees. This gives Mr Smith a total return of \$1,483.04 for the year.
