

Quarterly Disclosure Statement for 1 October 2014 to 30 September 2015

Grosvenor KiwiSaver Scheme International Share Fund

What is the purpose of this statement?

This statement provides key information about the Grosvenor KiwiSaver Scheme International Share Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The International Share Fund provides savers with the opportunity to achieve long-term capital growth through a diversified selection of international shares. The Fund will normally be 50% hedged back to New Zealand dollars, but this will be actively managed between 20% and 80%. This range may be changed from time to time. It aims to achieve a rate of return (net of fees but before tax) of at least 5% per annum above inflation (as measured by Statistics New Zealand's Consumer Price Index) over rolling ten year periods.



How has the fund performed in the past?


Example of how this applies to a member

Mr Smith had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Mr Smith received a return after fund fees and tax were deducted of \$619.00 (that's 6.19% of his initial \$10,000). Mr Smith also paid \$36.99 in membership fees. This gives Mr Smith a total return of \$582.01 for the year.

Notes

- 1. Returns in this statement are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax rate may be lower.
- 2. Fund fees are fees charged as a percentage of a member's interest in the fund (i.e. as a percentage of their KiwiSaver account balance).
- 3. Membership fees are the fixed dollar charges for membership in the KiwiSaver scheme. The Membership fee was reduced from \$3.33 per month to \$3.00 per month from 1 July 2014. From 18 September 2015, this fee will not be charged unless the balance of the member's account is greater than \$500.
