

Quarterly Disclosure Statement for 1 April 2015 to 31 March 2016

Grosvenor KiwiSaver Scheme Balanced Fund

What is the purpose of this statement?

This statement provides key information about the **Grosvenor KiwiSaver Scheme Balanced Fund**. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The Balanced Fund provides savers with the opportunity to invest in a combination of income and growth assets, in order to enhance returns over the long-term through capital gains. It aims to achieve a rate of return (net of fees but before tax) of at least 3% per annum above inflation (as measured by Statistics New Zealand's Consumer Price Index) over rolling seven year periods.

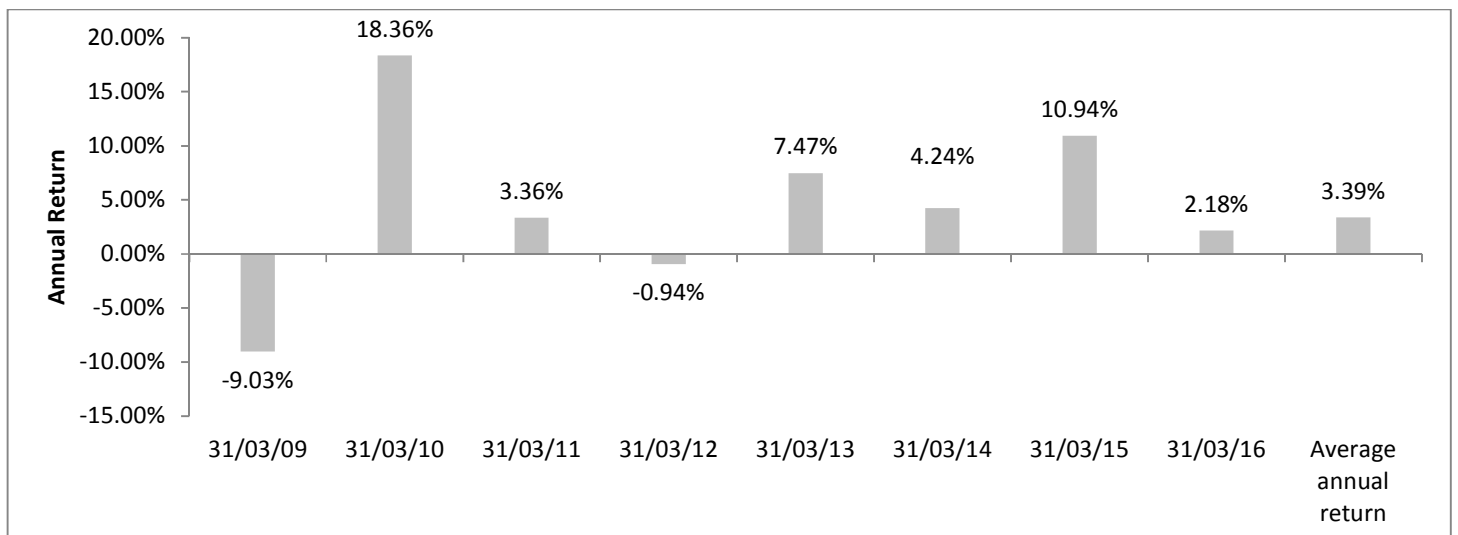

How has the fund performed in the past?

What fees were members charged?

The returns above are after deductions for **fund fees**². These fees were last totalled up for the year to 31 March 2015 and were:

Members were also charged **membership fees**³ of \$36.99 over the year to 31 March 2015.

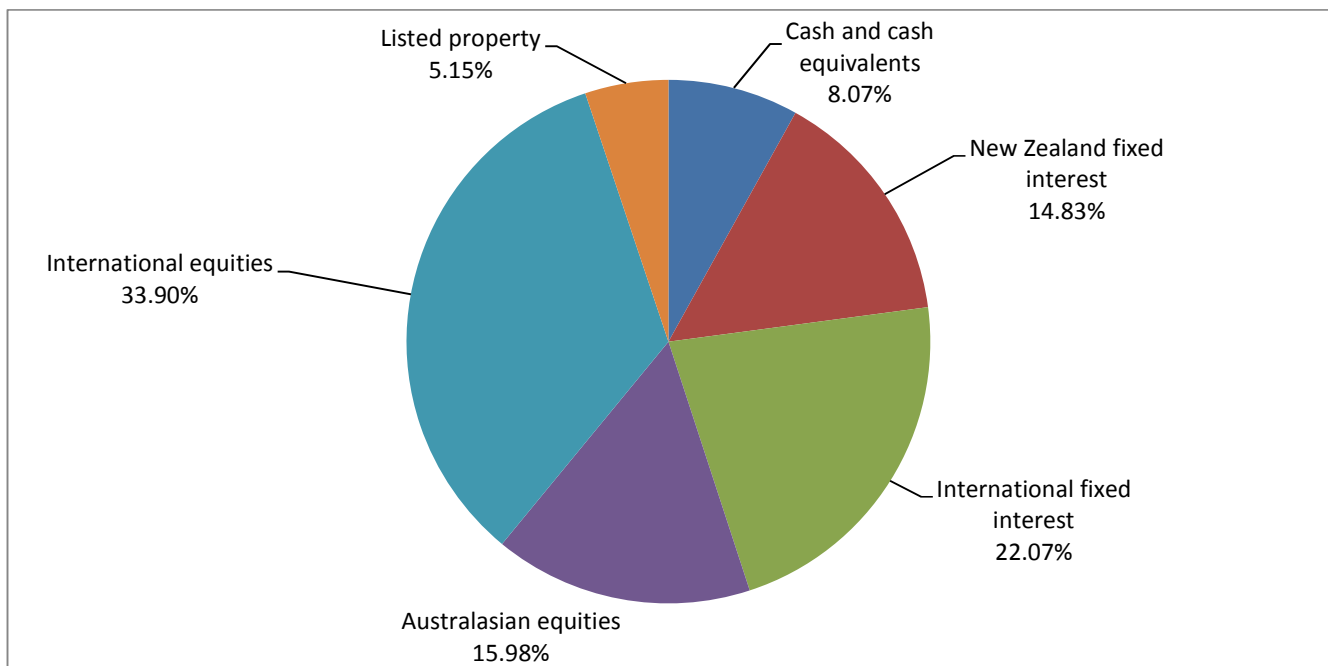
Example of how this applies to a member

Mr Smith had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Mr Smith received a return after fund fees and tax were deducted of \$218.00 (that's 2.18% of his initial \$10,000). Mr Smith also paid \$36.99 in membership fees. This gives Mr Smith a total return of \$181.01 for the year.

Notes

1. Returns in this statement are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax rate may be lower.
2. Fund fees are fees charged as a percentage of a member's interest in the fund (i.e. as a percentage of their KiwiSaver account balance).
3. Membership fees are the fixed dollar charges for membership in the KiwiSaver scheme. The Membership fee was reduced from \$3.33 per month to \$3.00 per month from 1 July 2014. From 18 September 2015, this fee will not be charged unless the balance of the member's account is greater than \$500.
