What is the purpose of this update?

This document tells you how the **Enhanced Cash Fund** has performed and what fees were charged. The document will help you to compare the fund with other funds. **Booster Investment Management Limited** prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Enhanced Cash Fund invests entirely in income assets. It is suited to investors looking for a low level of risk who are willing to accept a relatively modest level of returns.

What are the risks of investing?

Risk indicator for the Enhanced Cash Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets go up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



^{*}The manager's basic fee was temporarily reduced during the year ending 31 March 2022. We expect the total fund charges to have increased from the charges stated in this table. Please refer to the Booster KiwiSaver Scheme: Multi-sector Funds and Cash Fund PDS for expected annual fund charges.

The Enhanced Cash Fund has a membership fee of \$3.00 per month per investor. In total, during the disclosure year, this would be $$36.00 ($3.00 \times 12)$.

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). See the Booster KiwiSaver Scheme: Multi-sector Funds and Cash Fund PDS for more information about those fees.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Ruby had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ruby received a return after fund charges and tax were deducted of \$77 (that's 0.77% of her initial \$10,000). Ruby also paid \$36.00 in other charges. This gives Ruby a total return after tax of \$41 for the year.
