What is the purpose of this update?

This document tells you how the **Cash Portfolio** has performed and what fees were charged. The document will help you to compare the fund with other funds. **Booster Investment Management Limited** prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Cash Portfolio invests entirely in income assets. It is suited to investors looking for a low level of risk and are willing to accept a relatively modest level of returns.

What are the risks of investing?

Risk indicator for the **Cash Portfolio**:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets go up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?

Example of how this applies to an investor


Ruby had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ruby received a return after fund charges and tax were deducted of \$9 (that's 0.09% of her initial \$10,000). Ruby also paid \$0.00 in other charges. This gives Ruby a total return after tax of \$9 for the year.

This shows the types of assets that the fund invests in.


■ 100.0% Cash and cash equivalents
