

## Fund Update

### What is the purpose of this update?

This document tells you how the **Cash Portfolio** has performed and what fees were charged. The document will help you to compare the fund with other funds. **Booster Investment Management Limited** prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The Cash Portfolio invests entirely in income assets. It is suited to investors looking for a low level of risk and are willing to accept a relatively modest level of returns.

### What are the risks of investing?

Risk indicator for the **Cash Portfolio**:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets go up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

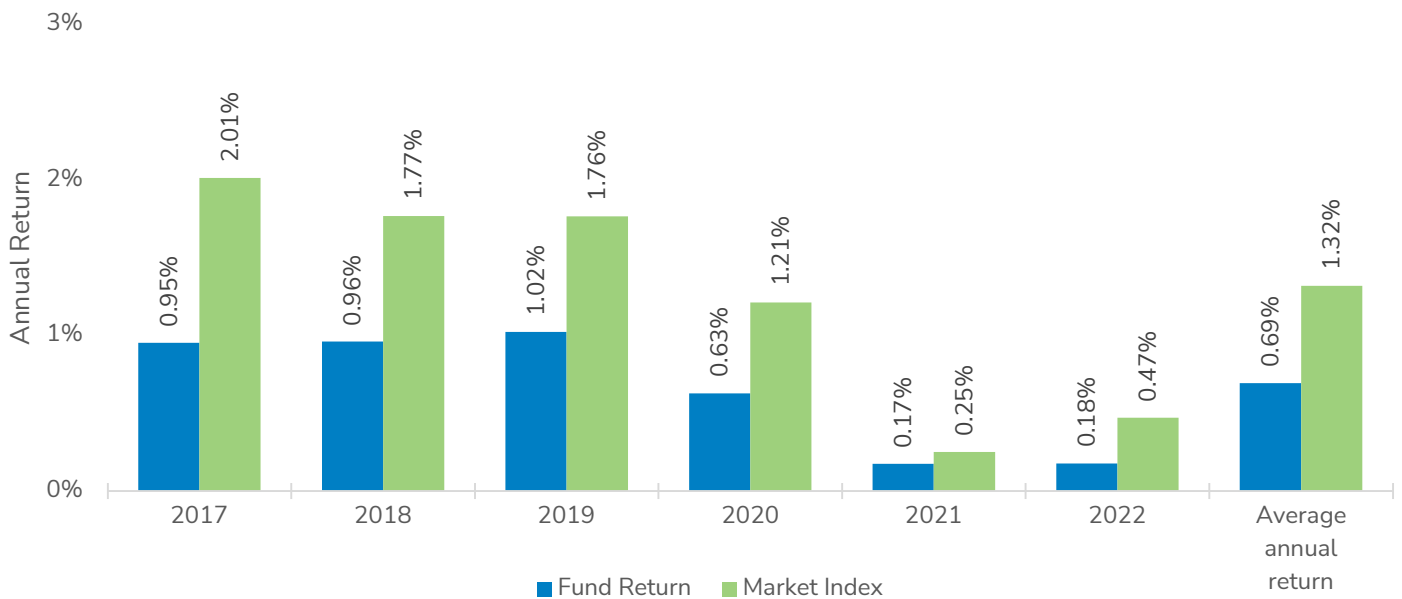
## How has the fund performed?

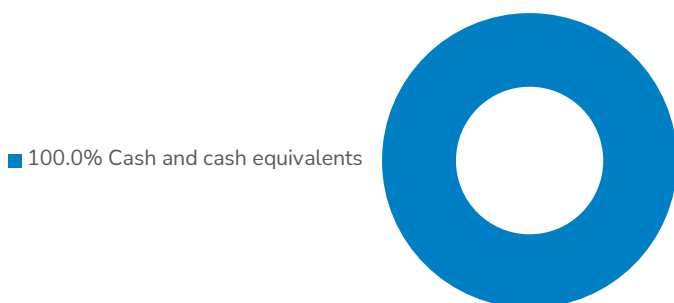
## Example of how this applies to an investor

Ruby had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ruby received a return after fund charges and tax were deducted of \$76 (that's 0.76% of her initial \$10,000). Ruby also paid \$0.00 in other charges. This gives Ruby a total return after tax of \$76 for the year.
