What is the purpose of this update?

This document tells you how the **Cash Portfolio** has performed and what fees were charged. Description of this fund

The Cash Portfolio is suited to investors who seek a modest positive return over both the short and long term. We aim to achieve this by investing entirely in income assets.

What are the risks of investing?

Risk indicator for the Cash Portfolio:



At the end of the year, Ruby received a return after fund charges and tax were deducted of \$216 (that's 2.16% of her initial \$10,000). Ruby also paid \$0.00 in other charges. This gives Ruby a total return after tax of \$216 for the year.


Actual Investment Mix
