

## Fund Update

### What is the purpose of this update?

This document tells you how the **Sterling Cash Portfolio** has performed and what fees were charged. The document will help you to compare the fund with other funds. **Booster Investment Management Limited** prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The Sterling Cash Portfolio is suited to investors who seek a low risk pounds Sterling investment with low to modest returns, domiciled in New Zealand and are transferring pension benefits or other funds and who want their funds to remain in pounds Sterling. We aim to achieve this by investing entirely in income assets, hedged to pounds Sterling.

### What are the risks of investing?

Risk indicator for the **Sterling Cash Portfolio**:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets go up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

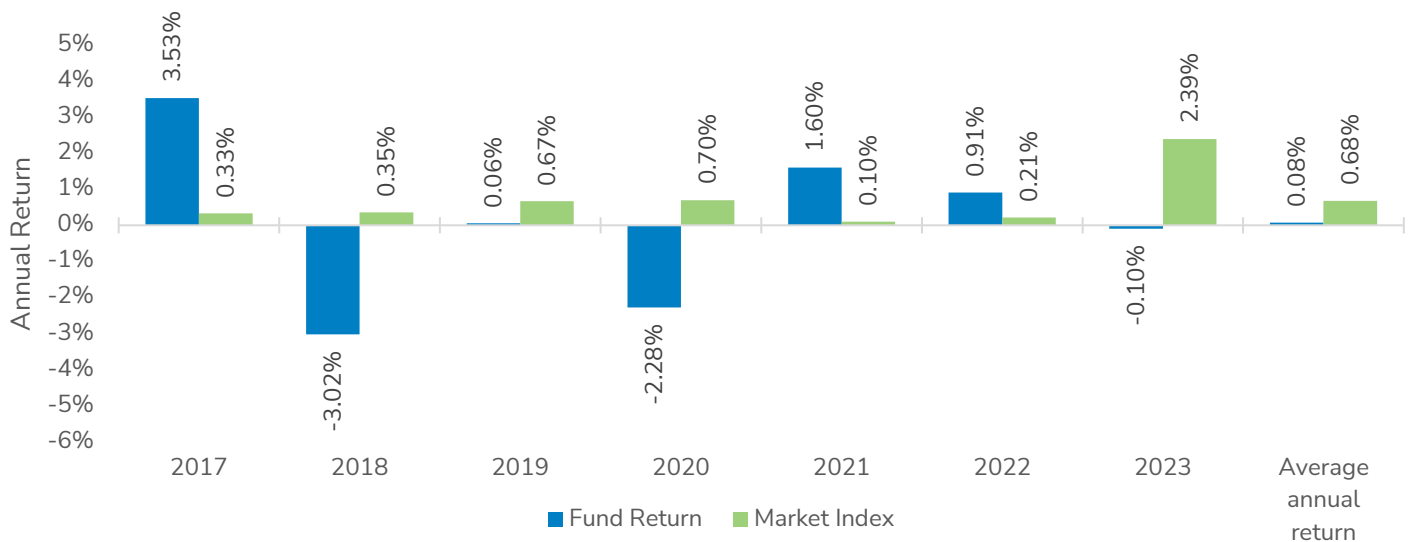

## Example of how this applies to an investor

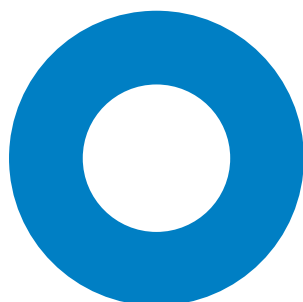
Ruby had £10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ruby received a loss after fund charges and tax were deducted of -£10 (that's -0.10% of her initial £10,000). Ruby also paid \$0.00 in other charges. This gives Ruby a total loss after tax of -£10 for the year.
