What is the purpose of this update?

This document tells you how the **Sterling International Share Portfolio** has performed and what fees were charged. This information is not audited and may be updated.

Description of this fund

The Sterling International Share Portfolio is suited to investors who seek potentially higher pounds Sterling denominated returns on average over long term periods (ten years plus), allowing for short to medium term ups and downs. We aim to achieve this by investing in a diversified selection of international equities, hedged to pounds Sterling.

What are the risks of investing?



This gives Ruby a total return after tax of £2,289 for the year.
