

## Fund Update

### What is the purpose of this update?

This document tells you how the **Cash Portfolio** has performed and what fees were charged. The document will help you to compare the fund with other funds. **Booster Investment Management Limited** prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The Cash Portfolio is suited to investors who seek a modest positive return over both the short and long term. We aim to achieve this by investing entirely in income assets.

### What are the risks of investing?

Risk indicator for the **Cash Portfolio**:

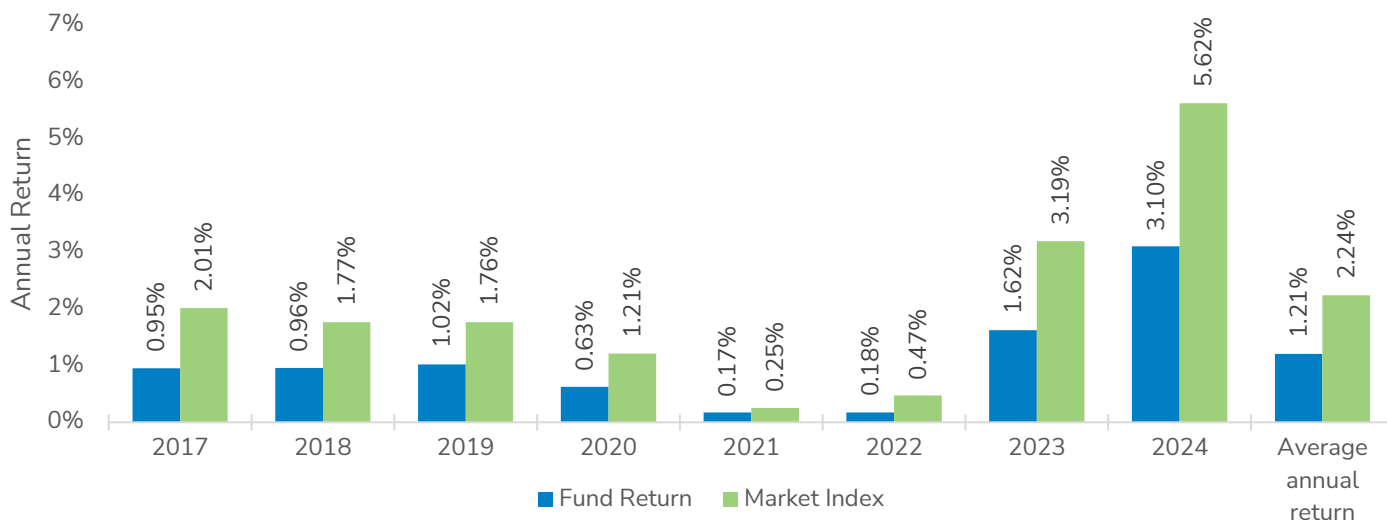
## How has the fund performed?

## Example of how this applies to an investor

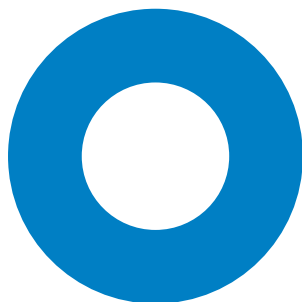
Ruby had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ruby received a return after fund charges and tax were deducted of \$318 (that's 3.18% of her initial \$10,000). Ruby also paid \$0.00 in other charges. This gives Ruby a total return after tax of \$318 for the year.
